- 7) Sign Board regarding 'No Smoking Zone', 'Here Smoking and Spitting is an offence' should be exhibited in front of the premise.
- 8) This Certificate issued is liable to be cancelled at any time on infringement if any of the above said conditions and for improper maintenance of sanitation, improper maintenance of the building as well as toilets in the premises.
- 9) That if any of all above conditions are not satisfied the Certificate given will be automatically cancelled.
- 10) This certificate should be **renewed every year**.
